## Note to Funds

The grant of £16,000 received from the Gunstone Trust in 2013/14 to assist with the building of the concrete skate facility at Redcotts Recreation Ground includes a clause that states the grant is given on the condition that the skate facility is retained for a minimum of 10 years. If the skate facility is disposed of before this then the grant is to be repaid less 1/10<sup>th</sup> of the grant for each year it was kept.

2905 Fund - Gunstone Trust - The trust has ceased now that they have achieved their objectives. Their remaining monies were donated to the Town Council for use on recreation facilities around the town.

Of the above funds only 2900 Fund - Town Centre Future Enhancement is a restricted fund. The money can only be spent for specific purposes as detailed in the service level agreement between East Dorset District Council, Wimborne BID and the Town Council. In the event that the monies are no longer required the balance must be returned to East Dorset District Council.
