48            **EAST DORSET DISTRICT COUNCILLORS' REPORTS**

Cllr D Morgan reported on a number of issues including the Allendale Centre, possible siting of solar panels at Mapperton, and ward budgets which had been increased from £2,000 to £4,000 per district councillor. However, this would result in there no longer being any money available for community grants.

Cllr S K Bartlett, as District Councillor, also referred to the increased ward budget of £4,000 which in his opinion would be unfavourable to single member wards. However, Members would be able to work in collaboration with one another to fund projects which covered more than one ward area.

He further reported at the Members' briefing prior to the last Planning Committee it was apparent that the developer of the land off the Cranborne Road had done everything required by legislation and therefore there were no grounds to object. He had raised a question on the cost of SANGs at the meeting.

Cllr Bartlett reported that the accommodation project for the District Council involving the Allendale Centre would go before the next Scrutiny Committee meeting and that currently it was very difficult to glean any information at all on this matter. Cllr Mrs P A Hymers asked whether he could request that the Town Council be kept up to date with developments regarding this project.
